Zone Descriptions

What is the home zone for years 7-8?

NOTE: THIS ZONE HAS BEEN AMENDED EFFECTIVE FROM 1 JANUARY 2025

(the MOE Education Counts website will be updated to show the new zone from 1 January 2025)

The zone boundary commences from Pukete Bridge/Wairere Drive (eastern side of the Waikato River only). Follow Wairere Drive to Gordonton Road (includes Raungawari Drive, Te Puroa Place, Takapu Place, Porima Way and Julie Court). From Gordonton Road the zone extends along Pukeroa Road (Pukeroa Road addresses are included) and across the Waikato Expressway to include Greenhill Road and Taha Lane (but no Pardoa Blvd addresses).

From the Pardoa Blvd/Waikato Expressway intersection, the boundary extends along the Expressway to the Horsham Downs Road overbridge (Rototuna Bridge). It then turns right to follow Horsham Downs Road and travels along Horsham Downs Road (including only the left side of Horsham Downs Road) to Ennion Rise. The boundary follows Ennion Rise to the Ennion Rise overbridge (Wairere Ki Haua Bridge), before turning right to again follow the Expressway to the Resolution Drive/Waikato Expressway intersection.

The boundary extends south down Resolution Drive (including only the eastern side of Resolution Drive) to the Ennion Rise/Resolution Drive intersection before turning west to follow Kay Road to River Road (including Oaktree Lane) and then taking a direct line to the Waikato River. The zone then follows the Waikato River south back to Pukete Bridge/Wairere Drive, where the zone commenced.

All streets within the boundary stated above are in zone.

Both sides of the in-zone roads above are included unless otherwise stated.



What is the home zone for years 9-13?

The zone boundary commences from Pukete Bridge/Wairere Drive (eastern side of Waikato River only). It follows Wairere Drive to Gordonton Road (including Raungawari Drive, Te Puroa Place, Takapu Place, Porima Way and Julie Court). From Gordonton Road the zone extends along Pukeroa Road (Pukeroa Road addresses are included) and across the Waikato Expressway to include Greenhill Road and Taha Lane.

The boundary follows Greenhill Road to its end and takes a direct line to No 291 Telephone Road, then a direct line to the end of Kiroa Road. From the end of Kiroa Road, it takes a direct line to the Waverley Road/Holland Road intersection. It then follows Waverley Road to Piako Road. From the intersection of Piako Road and Waverley Road, it takes a direct line to the intersection of Middle Road and Woodland Road.

It follows Woodlands Road into Law Road and Law Road through to the intersection with Whitikahu Road. It turns right into Whitikahu Road and then left into Orini Road, travelling through to the Woodward Road intersection (includes Lucien Place). It turns left into Woodward Road and follows to its end and then takes a direct line to No 327 Tenfoot Road. Then take a line southwest to No 302 Gower Road (Davies Road is not included). From No 302 Gower Road, take a direct line to the end of Redbrook Drive.

The boundary extends along Redbrook Drive into Gordonton Road and then into Lake Road. It follows Lake Road to the intersection with River Road, then crosses River Road into Sullivan Road. The boundary follows Sullivan Road to its end and takes a direct line to the Waikato River. Follow the Waikato River south back to Pukete Bridge/Wairere Drive, where the zone commenced.

All streets within the boundary stated above are in zone.

Both sides of all streets and roads included in the above description are included unless otherwise stated.
